Davis Place fire results in first fire fatality in 2 decades in Laconia

February 25 at 2247, Laconia was dispatched to assist Belmont at a structure fire (Belmont subsequently requested a first alarm). Before leaving quarters, the tones started again for Laconia, Gilford, and Belmont for a structure fire on Davis Place in Laconia. Lakes Region advised they could see a glow from the tower camera and they were receiving calls. In addition, Laconia was dispatched to a man down on Canal Street. Lt. Desrosiers requested Stewarts Ambulance to Canal Street. Laconia Engine 1 arrived on Davis Place at 2251 and reported heavy fire at the rear of a large, multi-family dwelling. Lt. Desrosiers requested a 2nd alarm. Crews were confronted with a two-story wood frame, 6-unit/townhouse-style, multi-family (120 x 32) with fire in the rear middle extending into two apartments, two floors, and overlapping the roof. LPD and residents advised a man was still in one of the five apartments. Lt. Desrosiers placed a 2 1/2" with 1 1/4" tip in the rear to knock down the exterior fire and make a transitional attack. He took the rest of the crew to Division A to start searches. He sent a two-person crew into 66A Davis; they were driven out. They then went to 66 Davis and searched Division 1. After searching Division 1, they started up the stairs to Div. 2 when the second floor flashed over. One firefighter did receive burns and the crew pulled out. Simultaneously, a second two-person crew was going in through a bedroom window to VES. They could not get in because of heavy fire. The fifth firefighter was pulling a 2" line to Side A to protect the search.

Gilford arrived and laid in a four-inch line. Lt. Madden and crew put a 2 1/2" into operation on Side A. He took part of his crew and searched Exposure A while Lt. Desrosiers and crew searched Exp. D. The two crews then attempted another attack into 66 and 66A with two hand lines. They made some progress but again were driven out. Lines were then flowed from the exterior to darken the heavy fire. Additional crews were assigned to Exposures A, A1, and D, D1 to pull ceilings and cut off the fire. The Weirs was sent to the roof to open the roof. They pulled a scuttle cover which vented heavy fire. Lt. Ellingson felt the roof was unsafe and pulled his crew. Fire was soon self-venting over the main fire area.



At this time there was a joint operation of defensive attack into 66 and 66A with offensive operations into both exposures. A major problem was the tin ceilings throughout the structure. Pulling ceilings to expose hidden fire was almost impossible. The 3-foot cockloft

From the Chief...

As I write this article the sun is shining, the snow is rapidly melting, and I believe we have finally turned the weather corner toward spring. With the new year, many of our projects are approaching completion and we anticipate starting new ones.



The simulcast system will be operational soon. All of the equipment has been installed at the transmitter sites and is operational. Testing the system has started and, along with the testing, is the necessary fine tuning to achieve the optimal signal output. Reprogramming of the field force radios is almost complete. Once the reprogramming is complete and the tuning more refined, a changeover date will be chosen. At that point, all departments will be notified as to the date and time to switch all radios to the simulcast channels for normal operation.

Processing incidents with the CAD system is continuing to improve. As with any new system, it takes time for the users to become highly efficient. We are well on our way to achieving that goal. The CAD website, where people can see current incident activity, is now available at www.lrmfacommcenter.no-ip.biz. This is accessible to the general public and is limited to the data shown on the screen. Departments can obtain a login that will allow them to access detailed information about their incidents. The FireHouse Software interface for automatic downloading of data into an incident report is also available now. The Belmont Fire Department has been using this interface with good results. Chief Parenti had written a white paper on the use and setup of the local application. He can be contacted for more information. Members of the LRMFA staff will be attending training near the end of April relating to how to modify the graphics for the maps and developing output reports from the system database.

Replacement of the existing radio control console is a priority project that is in its early stages. The current console is experiencing operational limitations and no longer has technical support available as the manufacturer no longer exists. LRMFA is currently working with a vendor to develop the necessary system configuration to meet both current needs and anticipated future needs. An EMPG grant is being applied for, which, if approved, will provide 50% of the necessary funding for this project. The goal is to have a new radio control console in place by early fall.

There have been a number of significant fires in the Lakes Region during this first quarter of 2014. Unfortunately, two of those incidents resulted in fatalities. From what I have observed personally from fires I was present at and from what I have heard from people at other fires, the dispatch staff and firefighter/EMTs of all of our Lakes Region departments performed well in doing a very difficult and dangerous job under difficult weather conditions. I want to commend you all for your excellent service!

Check out the LRMFA website and Facebook page and take advantage of the training that is available. It is provided to help you perform better and be safer while you are helping someone else in trouble. Stay Safe!!

Danbury is a rural town in the western part of the Lakes Region Mutual Fire Aid system. It was formed from part of the town of Alexandria to the north. In 1794, a group of Alexandria residents petitioned the state legislature to separate Alexandria into two towns due to the inconvenience of having a mountain divide the town, making it difficult for all the residents to gather in a single place. The petition was granted in 1795, and the lower piece was incorporated as Danbury in that year. Its name was suggested by a settler from Danbury, CT. More land was later added to Danbury from Hill and Wilmot. The town now is 37.7 square miles with a population of around 1,200.

The Danbury Volunteer Fire Department was established in 1946 and funded by the town beginning in 1947. In 1948, the town purchased a grain storage building and converted it to be used by the highway department and the fire department. Eventually the highway department moved out but the fire department is still there, having added on to each end of the 100+ year-old building in 1975. A new engine, due next year, will necessitate raising the roof!



The department has always been budget conscious. The original equipment consisted of two trucks and a privately owned 18-wheeler was used as a tanker. Until 1975 they built their own apparatus! The highway department is still using a 1965 tanker to water roads!

Danbury has always been supportive of the department and has done a good job of supplying new apparatus when requested. Through generous donations, the department has been able to acquire essential equipment, such as a thermal imaging camera, auto extrication equipment, technical rescue gear,

defibrillators, and a snowmobile complete with trailer and toboggan. Most recently the department purchased a LifePak 15 monitor/defibrillator entirely with donations. This new piece of equipment allows the department to acquire and transmit 12 lead EKGs to local hospitals.

CHIEF A DANBURY NATIVE

Chief Austin is a lifelong resident of Danbury. He became involved with the department in 1991 at the age of 18, becoming Chief in 2006. He is a third generation firefighter of the department. His father is the former chief.

DEPARTMENT PERSONNEL

Danbury had an Explorer Post for many years, which helped bring younger members into the department. Many of the current members began here as Explorers. Unfortunately, due to low enrollment, the post lost its charter, thus making it harder to keep staffing levels where they need to be. The median age of the department has gone up and the department has only 19 active certified members.

However, the level of training, professionalism, and experience of those members is outstanding and Chief Austin spoke more than once about how the quality and dedication of his personnel has made his job as Chief much easier. He is "so grateful to them. It is a privilege to be surrounded by his people."

The department places a strong emphasis on training. Probationary members are required to achieve either Firefighter I or EMT certification, and a CDL license is required for all driver/operators. Most of his firefighters are trained above Firefighter I. The department does all of its continuing education and recertification courses in-house. The department training officer is a licensed instructor/coordinate and the annual training schedule ensures the department meets the standards of the National Registry of EMTs, the NH bureau of EMS, and any applicable OSHA requirements.

DEPARTMENT ACTIVITIES AND FUNDRAISERS

Last year the Danbury Volunteer Fire Department was privileged and honored to take over the Round for Ryan Golf Tournament. Ryan was the son of a department member and a member himself who was killed at his job in 2005. He was a much-loved young man and the tournament was begun to honor his memory. The tournament will take place in late summer.

A long-standing fundraiser is the Annual Turkey Supper and Gun Raffle, held each year on Columbus Day weekend.

The local "Battle of the Badges" softball game isn't a fundraiser but is a hotly contested game between the police department and fire department.

Players are even drafted — it's pretty serious competition!

THE FUTURE

Danbury is home to Ragged Mountain Ski Area. The ski area is expanding and plans to become an all-season resort. A golf course was added a few years ago and future plans include hotels, single family units, commercial structures, and other year round attractions. Danbury currently has 600 residential structures and the ski area has approval for 800 more! This will have a definite impact on all of Danbury and especially on emergency services.

Danbury Volunteer Fire Department holds its business meeting the first Monday of the month. Every Wednesday is devoted to training and equipment checks.

allowed fire to spread laterally. The roof needed cutting earlier in the operation, unfortunately, there were no firefighters to do the work.

Chief Carrier ran Division A, Chief Jones ran Exposure D, Captain Landry ran Division C, Chief Dexter was Safety. Chief Hayes and Chief Beland assisted as the Command Team; Chief Beattie was Command; Chief Erickson was his assistant.

Second alarm struck at 2252; 3rd alarm struck at 2254; 4th alarm struck at 2325; evacuation order given at 2345. Crews went back in for overhaul and extinguishment at 1:56 a.m.. Search for the missing person was ongoing until his body was discovered around 7:30 a.m.

All crews worked very hard in extremely cold conditions. Crews were rotated frequently to prevent fatigue. This was a tough long-duration fire (12 hours on-scene) and everyone performed admirably. CERT did a great job feeding the crews. LPD and DPW also did great work assisting at the scene.



EMS Update

The new spinal trauma protocol — now that's a paradigm shift!

The new spinal injury protocol being rolled out is a major paradigm shift from the way EMS has handled possible neck and back injuries for the past 40 years. It reminds me of a story Concord Fire Department Lt. Jeff Mellete told me my first week on the job:

A young woman was getting married and she really wanted to learn how to cook. Not having much experience in this area, she went to her mother and asked her to show her how to make the family's famous pot roast dinner. As they are preparing the meal, the mother cuts both ends off the roast and then throws the roast and both ends in the pan. The daughter asks the mother, "Why do you do it that way?" The mother stops and thinks for a moment then says, "I'm not sure, let's ask your grandmother." The two go to visit the grandmother and ask her why she cuts the ends off the roast before she cooks it. The grandmother pauses for a moment and then says, "Ah...I remember. When I was a young bride we were very poor and I only had one small pan in which to cook the pot roast. I had to cut both ends off so it would fit in the pan."

This story reflects a common saying in fire service circles: "150 years unimpeded by progress." Being a traditionalist, this is one of my favorite sayings and I am a fan of "bringing the horses back to the fire stations." I have to say EMS is changing rapidly, which is a good thing.

I have talked to many people about the upcoming "new" **Spinal Trauma Protocol**. Many EMS providers are concerned because it has long been drilled into our heads that "all MVC patients get back boarded. If you even suspect a possible spinal injury, you must back board the patient."

How have we reached the point where most people now won't have spinal precautions taken and, if they do, it will be putting a c-collar on and having them lie on the stretcher without a back board? And, when we come to a motor vehicle accident, we now should encourage the patient to self-extricate and then lie flat on our stretcher with a collar and no board.

We now have years of data. People who are far smarter than I and have letters after their name like PhD, MD, DO, have done a tremendous amount of research and have concluded we have done more harm than good with back boards.

Think of this: when someone breaks their arm, they tend to hold it against their body...this is called "self splinting." When someone breaks a bone in their neck, they tend to do the same thing by limiting movement.

It is clear that:

- There is no evidence placing patients on a back board improves their outcome.
- If spinal damage has already occurred, minimal movement of the spine won't make it worse.

• Patients who self-extricate from a motor vehicle put themselves through less spinal manipulation than we do by extricating them.

• Back boarding an obese patient or one with SOB can actually make them worse.

• Patients with conditions such as Kyphosis (hunchback) don't fit on a board and trying to make them can cause pain and trauma.

• Back boarding can cause increased intracranial pressure.

I certainly recommend everyone complete the training prior to implementing the protocol. However, I know everyone wants to know the gist of this new protocol, so here are the broad strokes:

• Back boards should only be used as extrication or carrying devices and can be substituted for a scoop stretcher or other more user-friendly devices in those situations.

• Full spinal precautions now typically mean a patient with a c-collar lying flat (if they can tolerate lying flat) directly on the stretcher with the stretcher straps securing them.

• Patients who can self-extricate from a MVC should be encouraged to do so and, with your assistance, lie flat directly on the ambulance stretcher.

• Back boards have no role in inter-facility transfers whatsoever.

• The old "Advanced Spinal Assessment Protocol" still exists. However, we are now using it to rule patients in to **Spinal Motion Restrictions** instead of ruling them off of a back board c-collar.

• Spinal Motion Restrictions usually will mean a c-collar and having the patient lie flat on the stretcher, with the stretcher straps securing them.

• KEDs and other short boards should not be used.

• If a back board is used for extrication, it should be removed once the patient is placed on the ambulance stretcher.

• The "standing take down" is eliminated.

• If a patient can't tolerate a c-collar, a towel/blanket roll can be used to help secure the c-spine.

The Bureau of EMS has created a very good online training program to help roll out this new protocol. It can be found on NHOODLE by going to <https://nhoodle.nh.gov/ola/>. NHOODLE works best with FireFox, Chrome or Safari, although I used Explorer and it seemed to work just fine for me. Once there, you will need to create an account. Under the "Courses" heading, choose "EMS," then choose "Continuing Education," then choose "Spinal Injury Protocol Course." It took me about an hour to complete the course. I found it to be well done, interesting, and informative. I highly recommend it. I will also be available to come to your department and do live classes if you prefer. Just have your Chief or Head of Service contact me.

The first quarter of 2014 in the system

It has been a long winter with never-ending cold and snow, just ask anyone with a glazed look in their eyes! The recent sunshine and warmer weather has been sorely needed.

It's also been a long winter within the Lakes Region Mutual Fire Aid system, with two fatal fires and countless accidents.

The year began in January with the Pemi Valley Water Extraction Team continuing to train — no matter the weather. The team was formed to give the northern part of the system quicker access to a water rescue team. After the 2008 flooding during which a 7-year-old girl died, departments in that part of the state decided it was time to form their own water rescue team.

Late in January the Laconia Fire Department pushed its new engine into the station. That may seem odd, as a new engine really should be capable of being backed into the station. However, it's a longstanding tradition within the department, dating back to days of horse-drawn firefighting equipment. The engine was dedicated to Capt. Robert Landry, a man who has, according to Capt. Chris Shipp, literally lived the fire service.

February saw a crash that shut down Route 104 in Bristol for hours. The driver of an SUV veered onto the shoulder and hit a DOT loader that was driving in the breakdown lane. The





Tuesday, May 6. Transitional Fire Attack. LRMFA.

Chief Steve Carrier, Gilford Fire Department, will discuss strategies and tactics associated with Transitional Fire Attack. He will review and share Gilford's newly-developed SOG and lead a discussion on how this aggressive, offensive tactic reduces firefighter heat stress. Size up, ventilation, and fire-fighting will be a big part of this learning opportunity.

In this program Chief Carrier will discuss the process Gilford Fire Department used to develop their Transitional Fire Attack policy. driver of the SUV was immediately airlifted to Dartmouth-Hitchcock, with his female passenger following later after a trip to LRGH.

On February 4, Barnstead Fire Department was busy fighting a house fire along with 4 other communities at the same time Waterville Valley and 7 other departments were fighting a 2-alarm fire in Waterville Valley. Both fires once again proved the value of mutual aid.

February 10 was a very sad day in the small community of Bridgewater where the first fire chief, Paul Morrill, and his wife, Betty, were killed in an early morning fire that tore through their home. The house was an old colonial and it was thought the fire began in a chimney. A rescue was attempted but to no avail. It was difficult for all involved and the couple will always be remembered for their dedication to Bridgewater.

Tilton-Northfield Fire Department brought its new chief on board in February. Chief Michael W. Sitar, Jr. had a 32-year-long career with the Tewksbury, MA fire department. He was chosen by a search committee comprised of Jim Clements (former head of Tilton School), Scott Davis (Tilton-Northfield Water Company commissioner), Kevin LaChapelle (Franklin Fire Department chief), Steve Bluhm (Northfield selectman), Joe Jesseman (Tilton selectman), and Joyce Fulweiler (Tilton town administrator). Chief Sitar was officially welcomed at his swearing-in ceremony on Feb. 12.

Gilford Lt. Dominic DeCarli was caught in the act — the act of giving, that is! He was awarded the "Caught in the Act" citation for his services to the town during the winter's many snowstorms. DeCarli went above and beyond by using his personal truck to plow hydrants, rescue stranded skiers, and plow around the fire station. His is just another example of all the things our firefighters do that is totally unrelated to running into a burning building. For another example, see the photo on page 16 of Andy Vermeersch of Campton-Thornton Fire-Rescue helping a little girl cross a very icy road.

February ended on a very sad note with another fatal fire, this one in Laconia. It was the first fatal since 1989. This 4-alarm blaze ripped through an apartment building on Davis Place. The building was a total loss and it took firefighters nearly five hours to find the victim after the fire was out due to the destruction. Laconia Fire Chief Ken Erickson praised the firefighters for their extraordinary efforts fighting a difficult fire in frigid conditions.

The first quarter ended with a 4-alarm fire in Gilman Iron Works on March 23. Gilman Chief Joe Hempel estimated 70-100 firefighters responded to the blaze, which took 2-1/2 hours to bring under control. The barn was a total loss and the attached home suffered severe damage and was uninhabitable.

So another quarter comes to an end. The snow has mostly melted and now we're easing into the brush fire season.
